

Your 2026-2027 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before processing Federal Student Aid, we must ask you to confirm the information you and your parents (if applicable) reported on your FAFSA. To verify that you provided correct information, we will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. **You and at least one parent (if a dependent student) must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the Ursuline College Office of Financial Aid.** We may ask for additional information after this has been submitted. If you have questions about verification, contact us as soon as possible so that your financial aid will not be delayed.

STEP 2 – HOUSEHOLD INFORMATION

DEPENDENT STUDENT - List the people in your parent's household including:

- 1) Yourself (the student)
- 2) Your parent(s) (including stepparent, if applicable) even if you are not living with them. Exclude a parent who has died or is not living in the household because of separation or divorce. Include a parent who is on active duty in the U.S. Armed Forces apart from the family.
- 3) Your parent(s) dependent children if: **a)** your parent(s) provide more than half of their support from July 1, 2026, through June 30, 2027, or **b)** the children live with the parents (or live apart because of college enrollment)
- 4) Other people living in your parent household **and** your parents provide more than half of their support from July 1, 2026, to June 30, 2027
- 5) For any household member, excluding parents, who will be enrolled at least half time in a degree, diploma, or certificate program at an eligible postsecondary educational institution any time between July 1, 2026, and June 30, 2027, include the name of the college.

INDEPENDENT STUDENT - List the people in your household including:

- 1) Yourself (the student)
- 2) Your spouse (if you are married)
- 3) Your dependent children if you provide more than half of their support from July 1, 2026, through June 30, 2027
- 4) Other people living in your household, **and** you provide more than half of their support from July 1, 2026, through June 30, 2027
- 5) For any household member, who will be enrolled at least half time in a degree, diploma, or certificate program at an eligible postsecondary educational institution any time between July 1, 2026, and June 30, 2027, include the name of the college.
